EDC PROPOSAL: Keweenaw Mountain Lodge Terrain Park

Don Kauppi: In a continuing effort to enhance activities in coordination with winterization of KML, the Copper Harbor Trails Club proposes construction of a Terrain Park at the KML. Aaron Rogers, Jeff Coltas and Sam Raymond researched attendance and usage at Mt. Bohemia citing approximately 65 to 70% of visitors to Mt. Bohemia are snowboarders. A snowboard facility at the KML would create a business opportunity and attract winter sports enthusiasts to the lodge. Complete proposal including construction costs is on file in the EDC office. See: KML Terrain Park Proposal. Construction costs: \$12,000.00 to \$13,000.00. Rails and Trails Club will contribute \$7,000.00 toward the project. Trails Club requests \$6,000.00 from EDC funds for the KML Terrain Park.

MOTION, John Sturos, support, Tom O'Callaghan to whole heartedly recommend to the Keweenaw County Board of Commissioners an allocation of funding in the amount of \$6,000.00 to construct *The Keweenaw Mountain Lodge Terrain Park* to support the Keweenaw Mountain Lodge during winter months.

GUEST SPEACKER: Trygve A. Ivesdal, MTU Adjunct Faculty, Renewable Energy Facilitator, Power &

- Utilizing available technology and expertise from MTU related to renewable energy systems,
 Keweenaw County could reduce energy costs at the KML, assist area businesses and
 municipalities to reduce energy costs
- Wisconsin has applied renewable energy technology. Energy Centers created to advocate technology and educate the public.
- Ivesdal, in conjunction with expertise at MTU, will be working with owners of the Eagle River Inn to establish "work sessions" and ultimately an alternative energy training center in Keweenaw County. Training Center would economically benefit Keweenaw County
- Wind generation installations in Keweenaw County on a mass scale are currently not
 economically feasible, but small scale, individual installations, in conjunction with solar
 applications may be effective
- Ivesdal will sent information regarding how the training center in Green Bay, Wisconsin began and how it is funded
