### **Communications Infrastructure**

- Shari Chase: Sent EDC members the Verizon web site information and instructions to request cellular service in Keweenaw County. Richard Schaefer recommended sharing the request information with residents, businesses, and tourists and to identify the Verizon entity responsible for compiling cellular service request data.
- Peg Kauppi agreed to serve on the Communications Infrastructure Sub Committee. Will develop a sign-up form which could be posted in area businesses and recreational sites for Keweenaw County tourists and residents to request cellular telephone service. Form to be presented to the EDC for approval.

## **Bio-mass Technology**

o Raymond Chase: KC Board of Commissioners approved EDC Bio-Fuel generating facility proposal. Contacted an engineer who is researching U.S. Department of Energy and U.S. Department of Agriculture Biomass Research and Development Initiative grants. Consulting fees are waived until potential grant funding is secured.
