- Keweenaw County Communications Infrastructure: Shari Chase No new information was received from Pasty.Net regarding upgrading internet services in Keweenaw County.
- Bio-mass Technology: Raymond Chase –Working with SER Engineering to secure a cost analysis for a bio-mass plant. Contacts made with potential buyers of bio-mass. Keweenaw County Board of Commissioners gave verbal approval to utilize Mt. Horace Greeley as a production site.
- Keweenaw County Recreation Trails: Raymond Chase- Keweenaw ATV Trails Maps were
  presented. Raymond and Shari Chase were thanked for working diligently to produce the maps.
  Trail dedication will be held on May 28, 2011 in Phoenix. Raymond has been invited to speak at

- KC Court House Renovation: Don Piche OMH Engineering, Hancock, Michigan, visited courthouse grounds. Courthouse is in dire need of structural repairs. OMH will attend the May Keweenaw County Board of Commissioners Meeting, research if the courthouse is designated historic building and recommend grants for historic buildings.

  or Controller: Pursuant to information related to statuary requirements, discussion was tabled

- Brownfield Redevelopment Authority: David Sundberg Louisiana Pacific and Mt. Horace
  Greeley moved into Phase II planning. No progress in obtaining a property deed from LP. Deed

  was presented. Approval to do assessments on the Gay School and a former gas station in
  Mohawk, Michigan was approved. Federal funding is no longer available for assessments.
  Future Brownfield funding is designated for clean up and rebuilding.
