OLD BUSINESS:

- Keweenaw County Communications Infrastructure: Shari Chase Cellular tower installation
 proceeding with negotiations being handled by the county and private entities. Keep KC
 Communications Infrastructure on the agenda as a review topic.
- Bio-mass Technology: Raymond Chase Met with David Sundberg. Cost analysis plan for bio-mass plant reviewed. Identified short rotation forestry and greenhouse technology as areas requiring additional research. As subcommittees, Don Secor and John Sturos were requested to research short rotation forestry. Ned Huwatschek and Richard Schaefer to develop a communications platform related to short rotation forestry. David Sundberg will research greenhouse technology. Three subcommittees formed.
- Keweenaw County Recreation Trails: Raymond Chase- *Keweenaw ATV Trail* dedication ceremony held on May 28, 2011 in Phoenix.
- Courthouse Renovation: Agenda item deleted. Issue being addressed by KC Board of Commissioners.
- Copper Harbor Trails Club: Peg Kauppi IMBA (International Mountain Biking Association) conference was held in Copper Harbor in May. IMBA impressed with the quality of Copper Harbor trails and the scenic setting. Bike manufacturer, TREK, will host an Annual Meeting in Copper Harbor, August, 2011. Marketing non-motorized trails in Keweenaw County important. Recommended forming a committee to explore innovative technology as a marketing strategy. Peg Kauppi and Shari Chase to serve on Marketing Committee.
- WUPPDR: Discussion related to annual funding. July agenda item.
